Sub: Upgradation in respect of above said school.

Sir/Madam,

With reference to your application dated 15.06.2011 and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for Senior School Certificate Examination for a period of three years w.e.f. 01.04.2011 to 31.03.2014 in the following subjects:-

- (a) Languages:- English (Core/Elective), Hindi (Core/Elective)
- (b) Elective Subjects:- Physics, Chemistry, Biology, Mathematics, Business Studies History, Political Science, Geography, Economics, Psychology, Sociology, Philosophy, Physical Education, , Accountancy, Commercial Art, Multimedia & Web Technology, Informatics Practice and Computer Science,.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:-

1. "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School Certificate Examination and changes made therein from time to time."
2. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
3. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.
4. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
5. It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
6. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
7. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to the Board every year.
8. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII depends upon campus area and facilities:-

Campus area	Enrolment	No. of Sections (pre-primary to X)	No. of Sections at Sr. Secondary (XI & XII)
(a) 1.0 acre	1250	02 in each class	04 in each class XI and XII
(b) 1.5 acre	1875	03 in each class	04 in each class XI and XII
(c) 2.0 acre	2500	04 in each class	04 in each class XI and XII

(d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.

9. School will provide physical facilities as per norms of the Board. The facilities reported at the time of last inspection are as given under:-

1. Area of school campus - 8093.71 sq. mtrs. (2 acres)
2. Total built up area - 7413.22 sq. mtrs.
3. Area of play ground - 2000 sq. mtrs.
4. No. of class rooms - 56 (7.77'x5.87')
5. Other rooms - 52 (25'x18')
6. No. of labs: Biology - 01 (11.99'x7.76')  
Physics - 01 (10.440'x11.840')  
Chemistry - 01 (11.995'x7.762')  
Maths - 01 (7.770'x5.800')  
Computer Science - 02 (7.77'x7.77')  
Composite Science lab - 01(10.44x11.840)
7. Size and number of books in the Library-01 Size(14.995'X7.770')sq. fts. No. of books 8253.

10. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.

11. Annual fee of Rs. 4500/- @ Rs.1500/- per annum for three years (01.04.2011 to 31.03.2014) be also remitted at an early date. (In case of overseas Independent school @ Rs. 5000/- p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/- p.a.)

12. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee of Rs. 25,000/- and other essential documents in the preceding year before the expiry of the date.

13. The school is eligible to open CBSE pattern classes XI w.e.f. 01.04.2011. Accordingly, 1st Batch of class XII of the school will be appeared at the CBSE Examination to be held in the year 2013.

14. Other conditions are as per Annexure 'A' enclosed.

15. Special conditions to be complied within three months:-

a) The school is required to submit extension of recognition from Directorate of Education, Delhi beyond 31.03.2012.
